## **2010 TALL SHIPS FESTIVAL BUILD A BOAT CONTEST**

### **CONTEST OVERVIEW**

Participants who build a model ship out of Ohio Lottery Instant Tickets (other materials may be used i.e. wood, tape, glue etc...for support and shape.) and meet the Contest criteria explained within will be eligible to win a variety of prizes. The Ohio Lottery is the Sponsor. Cleveland Rotary Centennial Celebration, LLC is the Organizer.

### **PROMOTIONAL & REGISTRATION PERIOD**

Entries will be accepted at the Ohio Lottery booth on location beginning Thursday July 8, 2010 through Saturday July 10, 2010 from 10:00 a.m. – 3:00 p.m. and Sunday July 11, 2010 10:00 a.m. – noon

## **ELIGIBILITY**

Contest is open to all entrants eighteen (18) years of age or older. Employees of the Cleveland Rotary Centennial Celebration, LLC ("Organizer"), Ohio Lottery employees, Lottery agents and Lottery commissioners, their affiliates, subsidiaries, participating vendors, promotion or advertising agencies, or any other company involved with the production, execution or distribution of the contest/prizes and their family members or persons living in their same household are ineligible to enter. This contest is void where prohibited and subject to all federal, state and local laws and regulations.

## **CONTEST**

The contest judging will begin at 3:00 PM and end prior to 5:00 PM on Sunday, July 11, 2010 at the Ohio Lottery Booth at the Port of Cleveland. Contest entries will be accepted from 10:00 AM through 3:00 PM on Thursday, July 8, 2010 through Saturday, July 10, 2010 and 10:00 AM through 12 Noon, Sunday, July 11, 2010. This contest will be running in conjunction with the 2010 Cleveland Tall Ships Festival (herein referred to as "festival") at the Port of Cleveland.

## **AGREEMENT TO THESE OFFICIAL RULES**

Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. By entering the Contest, entrant warrants that the submission is an original work, has not previously won any award, and that Entrant is aware of no conflicting rights in the submission including but not limited to copyright or other intellectual property right. Entrants agree that Organizer, Sponsor, their affiliates, parent companies, subsidiaries, agents or contractors, commissioners and their employees, officers and directors shall not be liable for injury, loss or damage of any kind resulting from participating in this promotion.

## **HOW TO ENTER AND REGISTER**

The actual model must be received, available and ready for display by 12 Noon on July 11, 2010 at the latest, but no earlier than 10:00 AM, Thursday, July 8, 2010. Entrants agree that, after judging, the ship models will be retained and become the sole and exclusive property of the Lottery with no compensation being due an entrant. A participant may enter more than one model but may only win one time. Organizer and Sponsor are not responsible for incomplete, invalid, illegible submissions or damaged models, which may be disqualified. Organizer and Sponsor reserve the right in their sole discretion to disqualify any individual they find to be tampering with the operation of the Contest or to be acting in violation with

these Official Rules. Entrants may only win one time during this promotion. Entrants must be 18 or older to enter. A release form must be signed and completed by the individual at the time their entry is dropped off.

### **DISPLAY, JUDGING & SELECTION OF WINNERS**

All entries will be on display at the festival on Thursday, July 8, 2010 from 10:00 AM until 5:00 PM, Sunday, July 11, 2010. Judging will take place during this time. Winners will be announced at the conclusion of the judging period. Winners need not be present.

An independent panel of judges will review the entries and the potential winners will be selected based on a composite score using some or all of the following criteria (“Judging Criteria”):

- Workmanship / Originality (25%)
- Realistic Look (25%)
- Use of Colors (25%)
- Balance of Lottery Tickets with other materials (25%)

A panel of objective judges selected by the Organizer will score all eligible Contest Entries based on the Judging Criteria and will select the Potential Winners prior to 5:00 PM on July 11, 2010 at the festival. Winning is contingent upon fulfilling all requirements of these Official Rules and Organizer’s and Sponsor’s decisions as to the administration of the Contest and prize awards are final. Organizer will notify the Potential Winners as soon as possible, in accordance with the information provided by an Entrant. In the event that Entrant’s telephone number or address changes during the Contest Period and the entrant is not present at time of the announcement of winners, it is Entrant’s responsibility to notify Organizer of such change. Potential Winners must sign and return an Affidavit of Eligibility and a Publicity/Liability Release within Seven (7) days of receipt of those documents or prize may be forfeited. In the event that any prize notification is undeliverable, Organizer is unable to contact a Potential Winner, or response to a prize notification is not received within Seven (7) days of its issuance, the prize may be forfeited. Where a prize is forfeited, the Entrant with the next highest score in accordance with the Judging Criteria will be chosen as an alternate winner. All confirmed winners will be posted on the 2010 Cleveland Tall Ships Festival and Ohio Lottery web sites on or about August 1, 2010.
